

## **ACD Telecom, LLC.**

### **NAICS: 334220**

Radio and Television Broadcasting and Wireless Communications Equipment Manufacturing; This industry comprises establishments primarily engaged in manufacturing radio and television broadcast and wireless communications equipment. Examples of products made by these establishments are: transmitting and receiving antennas, cable television equipment, GPS equipment, pagers, cellular phones, mobile communications equipment, and radio and television studio and broadcasting equipment. ACD's team has designated two people to engage and communicate with two vendors on their trunking radio system to for purchase and / or upgrade to APCO Project 25 compliant Trunking Radio System.

### **NAICS: 541330**

Engineering Services; This industry comprises establishments primarily engaged in applying physical laws and principles of engineering in the design, development, and utilization of machines, materials, instruments, structures, processes, and systems. The assignments undertaken by these establishments may involve any of the following activities: provision of advice, preparation of feasibility studies, preparation of preliminary and final plans and designs, provision of technical services during the construction or installation phase, inspection and evaluation of engineering projects, and related services.

### **NAICS: 541513**

Computer Facilities Management Services; This U.S. industry comprises establishments primarily engaged in providing on-site management and operation of clients' computer systems and/or data processing facilities. Establishments providing computer systems or data processing facilities support services are included in this industry. We are also planning to hire an employee who specializes in Computer Systems Management, Database Management, Fiber Optics and Telephone System Design and Installations, etc.

### **NAICS: 541519**

Computer disaster recovery services; This U.S. industry comprises establishments primarily engaged in providing computer related services (except custom programming, systems integration design, and facilities management services). Establishments providing computer disaster recovery services or software installation services are included in this industry. Again the new staff should be able to assist us in this field. Also, we can work with the States of Louisiana, Mississippi, Alabama and Florida to provide computer disaster recovery services post natural disasters such as Hurricanes.

### **NAICS: 541611**

Administrative Management and General Management Consulting Services; This U.S. industry comprises establishments primarily engaged in providing operating advice and assistance to businesses and other organizations on administrative management issues, such as financial planning and budgeting, equity and asset management, records management, office planning, strategic and organizational planning, site selection, new business startup, and business process improvement. This industry also includes establishments of general management consultants that provide a full range of administrative; human resource; marketing; process, physical distribution, and logistics; or other management consulting services to clients. ACD's team has three people who work on this job. We also have performed projects that fall under this category, such as, but not limited to, City of Louisville / Jefferson County, KY, Metropolitan Washington Airports Authority (MWAA), etc.

### **NAICS: 541618**

Telecommunications Management Consulting Services; This U.S. industry comprises establishments primarily engaged in providing management consulting services (except administrative and general management consulting; human resources consulting; marketing consulting; or process, physical distribution, and logistics consulting). Establishments providing telecommunications or utilities management consulting services are included in this industry. ACD's team has four people who work this job. We also have present projects that fall under this category, such as, but not limited to, State of Oklahoma Department of Public Safety, Maui County Police Department, HI, Clay County Sheriff's Office, Metropolitan Washington Airports Authority (MWAA), Spartanburg County, SC, etc.

### **NAICS: 541690**

Other Scientific and Technical Consulting Services; This industry comprises establishments primarily engaged in providing advice and assistance to businesses and other organizations on scientific and technical issues (except environmental).

**NAICS: 541990**

All Other Professional, Scientific, and Technical Services; This industry comprises establishments primarily engaged in the provision of professional, scientific, or technical services (except legal services; accounting, tax preparation, bookkeeping, and related services; architectural, engineering, and related services; specialized design services; computer systems design and related services; management, scientific, and technical consulting services; scientific research and development services; advertising, public relations and related services; market research and public opinion polling; photographic services; translation and interpretation services; and veterinary services).

**NAICS: 813319**

Public Safety Advocacy; This U.S. industry comprises establishments primarily engaged in public safety advocacy organizations, social advocacy (except human rights and environmental protection, conservation, and wildlife preservation). Establishments in this industry address issues, such as peace and international understanding; community action (excluding civic organizations); or advancing social causes, such as firearms safety, drunk driving prevention, drug abuse awareness. These organizations may solicit contributions and offer memberships to support these causes. Presently, we are a member and active participant of the National Public Safety Telecommunicates Advisory Committee (NPSTAC), Association of Public-Safety Communications Officials-International, USWP8A, ITU-8 (a) and a past member and participant of the Public Safety National Coordination Committee (NCC), Public Safety Wireless Advisory Committee (PSWAC), International Municipal Signaling Association (IMSA).

**NAICS: 921190**

Other General Government Support; This industry comprises government establishments primarily engaged in providing general support for government. Such support services include personnel services, election boards, and other general government support establishments that are not classified elsewhere in public administration. Due to our present state and local government clients' Statement of Work and / or Projects, we believe we are performing this particular service already so it will be a natural and smooth transition for ACD Telecom provide general support for the federal agencies as well.

**NAICS: 926130**

Regulation and Administration of Communications, Electric, Gas, and Other Utilities; This industry comprises government establishments primarily engaged in the administration, regulation, licensing and inspection of utilities, such as communications, electric power (including fossil, nuclear, solar, water, and wind), gas and water supply, and sewerage. ACD's team has five people who do this job. We also have present projects that fall under this category, such as, but not limited to, Will County, Illinois, Oregon State Police, Utah Communications Agency Network (UCAN), State of New York Statewide Wireless Network, Metropolitan Washington Airports Authority (MWAA), Oregon State Police, Cities of Norman and Edmond, Oklahoma, State of Oklahoma Department of Public Safety, etc.

**NAICS: 926150**

Standards setting and management Services; This industry comprises government establishments primarily engaged in the regulation, licensing, and inspection of commercial sectors, such as retail trade, professional occupations, manufacturing, mining, construction, and services. Included in this industry are government establishments maintaining physical standards, regulating hazardous conditions not elsewhere classified, and enforcing alcoholic beverage control regulations. ACD's team has six people who do this job. We also have present projects that fall under this category, such as, but not limited to, Will County, Illinois, Oregon State Police, Utah Communications Agency Network (UCAN), State of New York Statewide Wireless Network, Metropolitan Washington Airports Authority (MWAA), etc.
